Pursuant to California Labor Code section 3352(a)(16)(A)(i), I hereby certify that I am a corporate officer or member of the board of directors (as defined in the California Corporations Code) of the above-named insured corporation and that I either (1) own at least ten percent (10%) of the issued and outstanding stock of the above-named insured corporation, or (2) own at least one percent (1%) of the issued and outstanding stock of the corporation if my parent, grandparent, sibling, spouse, or child owns at least ten percent (10%) of the issued and outstanding stock of the corporation and am covered by a health insurance policy or a health service plan. By executing this waiver, I elect to be excluded from the insured corporation's workers' compensation insurance policy with the above-named insurer. I understand and agree that this waiver will be effective upon the date of receipt and acceptance by the named insurer; that the insurer may elect to backdate acceptance of the waiver up to 15 days prior to the date of receipt of the waiver; and that this waiver shall remain in effect until I provide the insurer with a written withdrawal of this waiver. I understand and agree that by signing this waiver, I will not be entitled to coverage under the insured corporation's workers' compensation policy with the above-named insurer if an employment-related injury occurs.
